### FORM OF BYLAWS OF THE HOMEOWNERS ASSOCIATION

BY-LAWS

OF VISTA AT FOREST LAKE HOMEOWNERS ASSOCIATION, INC.

#### ARTICLE I. NAME AND LOCATION

The name of the opporation is Bella Vista at Forest Lake Homeowners Association, Inc., (the "Association"). The principal office of the carporation shall be located at 557 N. Wymere Road, Suite 102, Maitland, Florida 32751, or at such other place as is designated by the Board of Directors of the Association (the "Board"), but meetings of members and directors may be held at such places within or without the State of Florida as may be designated by the Board.

# EFINITIONS

The definitions as set out in the Declaration Covenants, Conditions and Restrictions of Bella Vista (the "Declaration") are hereby incorporated by referen

### MEETINGS OF MEMBERS

Section 1. Annual Meetings. al meeting of the members shall be held within one (1) year from the date of incorporation of the Association sach subsequent regular annual meeting of the members shall be held on the same day of the same month of each year thereafter, at the hour of seven o'clock, P.M. If the day for the annual meeting of the members is a legal holiday, the meeting will be held at the same hour on the first day following which is not a legal holiday.

Special Meetings. Special meetings of the members may be called at any time by the president or by the Board, or upon written request of the members who are entitled to vote one-fourth (1/4) of all of the total voting interests of the Association.

Section 3. Notice of Meetings. Written notice of each meeting of the members shall be given by, or at the accretance of the accretance of person authorized to call the meeting, by mailing a copy of such notice, postage prepaid, at least streen (15) days before such meeting to each member emided to vote thereat, addressed to the member's address last appearing on the books of the Association, or supplied by such member to the Association for the purpose of notice. Such motife shall specify the place, day and hour of the meeting, and, in the case of a special meeting, the purpose of the meeting.

Section 4. Quorum. The presence at the meeting of members entitled to cast, or of limited proxies entitled to cast, thirty percent (30%) of the total voting interests of the Association shall constitute a quorum for any action except as otherwise provided in the Articles of Incorporation of Beila Vista at Forest Lake Homeowner's Association, Inc. (the "Articles"), the Decaration, or these By-Laws. If, however, such quorum shall not be present or represented at any meeting, the members eptitled to vote thereat shall have the power to adjourn the meeting from time to time, without notice other than announcement at the meeting, until a quorum as aforesaid shall be present or be represented. Unless otherwise provided in these By-Laws, Articles or Declaration, decisions shall be made by a majority of the voting interests represented at a meeting at which a quorum is present.

Proxies. At all precious of members, each member may vote in person or by limited proxy. All proxies shall be in writing and filed with the sectionry. To be valid, a proxy must state the date, time, and place of the meeting for which it was given, and must be street by the authorized person who executed the proxy. Every proxy shall be effective only for the specific meeting for which regionally given, as the meeting may be lawfully adjourned and reconvened from time to time, and automatically express the date of the meeting for which it was originally given. A proxy is revocable at any time at the pleasure of the homeowner who executes it. Limited proxies may also be used for vutes taken to amend the Articles or By-Laws after that requires or permits a votes of the homeowners.

### ARTICLE IV TERM AND REMOVAL OF DIRECTORS

Section 1. Number. The affairs of this Association shall be managed by an initial board of three

(3) directors. Deceafter the Board of Directors shall consist of at least three (3) members.

Tenn of Office. The term of office for all directors is one (1) year. The initial

directors of the Association set forth in the Articles shall hold office until the first annual meeting.

Removal. Any director may be removed from the Board, with or without cause, by a majority vote of the members of the Association. In the event of death, resignation or removal of a director, his successor shall be selected by the remaining members of the Board and shall serve for the unexpired term of his producessor.

Section 4. Compensation. No director shall receive compensation for any service he may render to the Association. However, any director may be reimbursed for his actual expenses incurred in the performance of his duties.

## ARTICLE V NOMINATION AND ELECTION OF DIRECTORS

Nomination I. Nomination. Nomination for election to the Board of Directors shall be made by a Nominating Committee. Nominations may also be made from the floor at the annual meeting. The Nominating Committee shall consist of a Chairman, who shall be annual meeting of the Board of Directors, and two or more members of the Association. The Nominating Committee shall be appointed by the Board of Directors prior to each annual meeting of the members, to serve from the close of such annual meeting until the close of the next annual meeting and such appointment shall be announced at each annual meeting. The Nominating Committee shall make as many nominations for election to the Board of Directors as it shall in its discretion determine, but not less than the number of vacancies that are to be filled. Additionally, any member of the Association may be made from among members or non-members.

Section 2. Election to the Board of Directors shall be by secret written ballot. At such election the members or their proxies may cast, in respect to each vacancy, as many voices as they are emitted to exercise

under the provisions of the Declaration. The persons receiving the largest number of votes shall be elected. Cumulative voting is not permitted.

Section 3. <u>Use of Proxy.</u> For election of members of the Buard of Directors, members of the Association which pote in person at a meeting of the homeowners or by a ballot that the homeowner personally casts.

#### ARTICLE VI MEETINGS OF DIRECTORS

Meetings of the Board of Directors shall be on a regular basis at such place and hour as may be used from time to time by Resolution of the Board. Should said meeting fall upon a legal holiday, then that meeting shall be hole at the same time on the next day which is not a legal holiday.


Special Meeting. Special meetings of the Board of Directors shall be held when called by any two directors, after not itselfan three (3) days notice to each director, or when called by at lease ten percent (10%) of the total voting interests of the Association. Notice of a special meeting must include a description of the purpose or purposes for which the meeting is called. Business conducted at any such special meeting is limited to the purposes described in the notice of the meeting.

Section 3. Output. A majority of the number of directors shall constitute a quorum for the transaction of business. Every act or decision one or made by a majority of the directors present at a duly held meeting at which a quorum is present shall be regarded as the respect the Board.

Section 4. Action Without a Meeting, any action which may be required or permitted to be taken at a meeting of the Board of Directors may be taken without a meeting if a consent in writing, setting forth the action so taken is signed by all the members of the Board of Director's such consent shall be placed in the minute book of the Association with the minutes of the Board of Directors. Any action to approve shall have the same effect as though taken at a meeting of the directors.

Section 5. Notice to Members. Meetings of the Board of Directors shall be open to all members except for meetings between the Board and its attorney with respect to proposed or pending litigation where the contents of the discussion would otherwise be governed by the attorney-client privilege. Notice of meetings shall be posted in a conspicuous place on the Association property at least 48 hours in advance, except in an emergency. Notice of any

meeting in which assessments against parcels are to be established shall specifically contain a statement that assessments shall be considered and a statement of the nature of such assessments.

### ARTICLE VIII OFFICERS AND THEIR DUTIES

Enumeration of Offices. The officers of this Association shall be a president and vice-Section 1. president, who shall at all times be members of the Board of Directors, a secretary, and a treasurer, and such other officers as the Board may from time to time by resolution create. Said officers need not be members of the Association in order to be ordalified to hold any office described above. Election of Officers. The election of officers shall take place at the first meeting of the Board of Directors following each annual meeting of the members. Term. The officers of this Association shall be elected annually by the Board and each Section 3. shall hold office for one (f) year unless he or she shall sooner resign, or shall be removed, or otherwise disqualified to serve. Special Appointments. The Board may elect such other officers as the affairs of the Section 4. Association may require, each of whom shall hold office for such period, have such authority, and perform such duties as the Board may, from time to time, determine Resignation and Removal. Any officer may be removed from office with or without Section 5. ge giving written notice to the Board, the president or the secretary. cause by the Board. Any officer may resign at any Such resignation shall take effect on the date of the such notice or at any later time specified therein, and unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective. in any office may be filled by appointment by the Board. The Vacancies. A vacan Section 6. officer appointed to such vacancy shall serve for the remarked of the term of the officer he replaced. Multiple Offices. The offices of secretary and treasurer may be held by the same Section 7.

Section 8.

<u>Duties.</u> The duties of the officers are as follows:

#### President

The president shall preside at all meetings of the Board of Directors; shall see that orders and ns of the Board are carried out; shall sign all leases, mortgages, deeds and other written instruments sign all checks and promissory notes.

#### Vice-President

(in the president shall act in the place and stead of the president in the event of his absence, inability or refusal to set and shall exercise and discharge such other duties as may be required of him by the Board.

#### Secretary

The secretary shall record the votes and keep the minutes of all meetings and proceedings of the Board (c.) and of the members acceptibe corporate seal of the Association and affix it on all papers requiring said seal; serve notice of meetings of the Board and of the members; keep appropriate current records showing members of the Association together with their addresses, and shall perform such other duties as required by the Board.

Treasurer

The treasurer shall receive and deposit in appropriate bank accounts all monies of the Association and (d.) shall disburse such funds as directed probabilition of the Board of Directors; shall sign all checks and promissory notes of the Association; keen more books of account; cause an annual audit of the Association books to be made by a public accountant authorizing pletion of each fiscal year, and shall prepare or have prepared an annual budget and a statement of incoper and expenditures to be presented to the membership at its regular annual meeting, and deliver a copy of each to the pembers.

#### ARTICLE COMMITTEES

The Association shall appoint an Architectural Control Communities, as provided in the Declaration, and a Nominating Committee, as provided in these By-Laws. In addition, the Board of Directors shall appoint committees as deemed appropriate in carrying out its purpose.

#### ARTICLE X BOOKS AND RECORDS

Inspection and Copying. The official records of the Association shall be maintained Section 1. within the State of Plorida and must be open to inspection and available for photocopying by members or their authorized agents a reasonable times and places within ten (10) business days after receipt of a written request for access. This requirement may be satisfied by having a copy of the official records available for inspection or copying in the subject eciation may adopt reasonable written rules governing the frequency, time, location, notice, and ons, and may impose fees to cover the costs of providing copies of the official records, including, without limitation, the copying. The Association shall maintain an adequate number of copies of the Articles, By-Laws and Declaration to ensure their availability to members and prospective members, and may charge only its actual costs for reproducing and dunishing these documents to those persons who are entitled to receive them. Official Records. The Association shall maintain each of the following items, when Section 2. applicable, which constitute the official records of the Association: Copies of any plans, and warranties related to improvements constructed on the Common Areas or other property that the Association is obligated to maintain, repair or replace.

- A book or books that contain the minutes of all meetings of the Association, of the Board of Directors (f.) and of members, which minutes shall be retained for a period of not less than seven (7) years.
- A current roster of all members and their mailing addresses and parcel identifications. (g.)
- All insurance policies of the Association or a copy the profifer a period of not less than seven (7) years. (h.)

A current account and a periodic statement of the account for each member of the Association, designating the name and current address of each member who is obligated to pay the due date and amount of each assessment or other charge against the member, the date and amount of each payment on the account, and the balance due.

other records that identify, measure, record, or communicate financial (4.) information of the Association.

#### ARTICLE XI ASSESSMENTS


As more fully provided in the Declaration each member is obligated to pay to the Association all assessments as listed in the Declaration, which are secured by a containing lien upon the property against which the assessment is made. Any assessments which are not paid when due shall be delignent. If the assessment is not paid within thirty (30) days after the due date, the assessment shall bear interest at the maximum and allowable by law and the Association may bring an action at law against the Owner personally obligated to pay the same or fereclose the lien against the property, and interest, costs, and reasonable attorney's fees of any such action and be added to the amount of such assessment. No Owner may waive or otherwise escape liability for the assessment provided for herein by non-use of the Common Area or abandonment of his Lot.

#### ARTICLE XII CORPORATE SEAL

### ARTICLE XIII AMENDMENTS

Amendments. These By-Laws may be amended, at a regular or special meeting of the Section 1. members, by vote of two-thirds (2/3) of the voting interests of the Association, except that the Federal Housing Veterans Administration shall have the right to veto amendments while there is Class B membership Precedence.
